On behalf of the John Patrick Flanagan Foundation (JPFF), I am pleased to present our Spring 2014 newsletter that provides an update on our activities and successes over the past year.

Through the kindness and generosity of hundreds of individuals and families, we've provided more than \$85,000 to support a variety of programs and organizations that help disadvantaged children and families in our region since our inception in 2009.

With your help, JPFF has enabled more than 2,000 kids from Bridgeport to go on field trips to the Audubon Society in Fairfield as part of the John Patrick Flanagan Trailblazers program. We've funded programming and college preparation assistance for inner city teens, helped economically-disadvantaged immigrant women and children learn English and life skills, supported children affected by HIV/AIDS, sponsored volunteer attorneys who work to place children in safe permanent homes and given scholarships to children who have a financial need as well as children who have lost a parent to cancer.

JPFF remains a living testament to the life and spirit of John Flanagan. We are proud to be working with so many organizations that are improving the lives of children and families in need throughout Fairfield County.

\$28,500 granted to six local organizations in 2013

In December of 2013, The John Patrick Flanagan Foundation voted to award \$28,500 in grants to a six local nonprofits that help disadvantaged children and families in our communities.

The most recent grants awarded are:

- CT Audubon Society Center at Fairfield (\$8,000) to fund the cost for the "JPFF Trailblazers Program," which enters its fifth year and provides Bridgeport public school students with transportation to the Nature Center for field trips focused on nature and science. Since the program began, more than 2,000 students have participated in the Trailblazers program.
- United in Hope Scholarship Fund (\$5,000) to fund a scholarship for graduating college-bound high school seniors who have lost a parent to cancer. This grant is jointly founded with the Chad A. Jacobs Memorial Foundation.
- Commence College Counseling (\$3,000) to support the organization's efforts to enhance their website. Commence helps highly motivated students in Bridgeport apply to college and navigate the scholarship and financial aid network.
- Wakeman Smilow-Burroughs Clubhouse in Bridgeport (\$7,000) to help fund teen counselors who provide programming at the Clubhouse in Bridgeport, including an afterschool job program, community service program, and high school and college prep support.
- Caroline House (\$4,500) to fund a nutritious snack program for the children in their preschool program.
- High School Scholarship of Fairfield (\$1,000) to fund an annual scholarship to a college-bound, high achieving student with economic need from Fairfield Warde High School.

In early 1994, I was looking to get involved in politics in Connecticut after living in Washington, DC and was directed by then-Attorney General Richard Blumenthal to get in touch with John Flanagan from his office.

John and I spoke a few times and I helped out with some small-scale events during the early part of the year. He was easy to talk to and always very entertaining to be around.

That summer, as the Democratic State Convention approached, John asked if I could help him and a few other folks prepare the Blumenthal presence in the basement of the Hartford Civic Center and I was happy to assist.

With the Convention on Saturday, the preparations had to be completed on Friday evening. And with so many candidates vying for a range of offices, space in the convention area was pretty limited. One of the odd convention rules stated that campaigns could not use anything 'extra' to post their materials up on the walls— you were not allowed to use ladders or chairs to get their posters and placards higher than any other candidate's.

Always the innovator, I watched John hoist a very attractive girl onto his shoulders to put the orange and blue Blumenthal posters higher than anything else in the room. They moved along the wall, talking, laughing, and positioning themselves to cover as much ground as they could.

As they moved toward me, the very attractive girl lost her balance and jumped off John's shoulders, and landed on my foot. As I expressed my discomfort, John and the very attractive girl laughed for what seemed to be an hour.

Then John said to me, motioning toward the very attractive girl, "Chris, have you met my sister Caitlin?"

I had not, and suddenly, my foot didn't hurt so much.

Five years later (after a bit of patience on my part...) Caitlin and I were married with John and his brother Matt joining my four brothers as ushers at our wedding on October 9, 1999.

So if it were not for John, I would not have met Caitlin, the love of my life and the mother of my incredible kids. My life would have gone in an entirely different direction and I cannot imagine I'd be as happy as I am today.




Thoughts of John: UCONN's Double National Championship

JPFF Grant Recipient Profile: Commence! College Counseling

Students working with Commence are seeking maximum financial aid and need strategic guidance to build college lists and tell their stories in compelling applications.

These students, mostly immigrants, children of immigrants, first generation to college, or raised in non-English speaking households lack an experienced family or any kind of support to help them through the selective admissions maze.

With Commence, these students, often served by overworked school staff, benefit from personalized mentoring and specialized guidance.

Commence College Counseling has been guiding highly motivated Bridgeport students through the selective college admission process for over seven years. Students like Joey, a daughter of Chinese immigrants who speak little English, worked tirelessly at Central Magnet, taking rigorous classes and succeeding. But, with parents who work seven days a week in their Chinese

take-out restaurant and lack knowledge of the college process, she was completely overwhelmed at the prospect of applying to college. Beginning in her junior year, week after week Commence worked with Joey one-on-one guiding her through testing strategies, college choices and multiple drafts of essays and the application. In her essays, Joey wrote of her hopes:

"I will go beyond the shameful cycle of illiteracy where sarcasm cannot be understood and where the oblivious rudeness of a customer stings. I will leap away from poverty to obtain the education that my parents could not."

Today, Joey is a junior double majoring in Economics and Psychology at Cornell University....and succeeding! For a kid who confided in us that she had never been more than an hour's drive from Bridgeport before we took her to see Cornell, now Joey has traveled to China with her Mandarin House, and Texas with her Tzu Ching Buddhist Club, where she is an officer. This past summer she co-managed the EEG section of her psychology lab, responsible for hiring and training research staff. This year Joey has moved off campus to Collegetown with friends and is currently looking for a summer internship.

Commence is proud to now be working with Joey's brother, Sam. Stay tuned for Sam's college plans!



United in Hope Scholarship

The Chad A. Jacobs Memorial Foundation and the John Patrick Flanagan Foundation have jointly founded the United in Hope Scholarship for students who have lost a parent to cancer. Graduating high school seniors who attend school in Fairfield or Westport are eligible to apply. Criteria for the scholarship include:

- Loss of Parent to Cancer
- Financial Need
- Attends High School in Fairfield or Westport, Connecticut
- Character of Applicant
- Academic Goals and Performance

Karen Jacobs, Chairperson of CAJF, commented on the scholarship, "Losing a parent to cancer is devastating enough, but adding the financial burden often incurred by this disease and the death of a parent can be debilitating to a family. Our goal in creating the United in Hope Scholarship is to provide financial support for students heading to college to help them be all they can be."

Current JPFF Endowment (May, 1, 2014) = \$ 452,000

2013 Fundraising Income = \$64,758.47

2013 interest, dividend and capital gain income =\$ 9,756.69 (All 2013 operating costs were covered by our investment income.)

2013 Operating Costs = \$ 6,888.42

costs, printing, postage and other minor costs. All other operating costs, including legal work, graphic design, website design, and all managerial and administrative costs were donated. JPFF is an all-volunteer organization.
